WHO SHOULD BE HELD ACCOUNTABLE FOR ELIMINATING THE HIGHGROVE SHERIFF?

If you have been following our articles on the elimination of the Highgrove Deputy Sheriff that was assigned exclusive to Highgrove, then you know that our Sheriff was eliminated 8 years ago and the Highgrove property owners are still paying \$120.00 per year for the Deputy Sheriff we no longer have. With all due respect to many of the employees of Riverside County who I have worked with for over 20 years, I want everyone to know that my criticism of Riverside County is aimed at their top leadership and not directed toward the rank in file Riverside County employees. I have made a lot of friends and acquaintances with many of these employees over the years when I hand delivered the Highgrove Happenings to the Riverside County Administration Building to floors 3, 4, 5, 8, 12 and 14 and to the Riverside County Annex on 14th St. across from the old Press Enterprise building. We want everyone, including each county department, to know what their leaders have been doing to the Highgrove people. This also applies to the top leaders of the Riverside County Transportation Commission including their Executive Director, Anne Mayer, Deputy Executive Director, John Standiford, and RCTC Chairman John Tavaglione who also happens to be the Riverside County Supervisor for Highgrove. It has been my long time privilege to volunteer for previous County

Supervisors Younglove, Mullen, Ashley, and a portion during Supervisor Tavaglione's jurisdiction. But things turned sour when I started asking Supervisor Tavaglione about the Sheriff that was eliminated without properly notifying the parcel owners and continued even further with the Highgrove MAC's subsequent request for an audit of our CSA 126 funds.

AUDIT:

On Aug. 5, 2015, as Chairman of the Highgrove Municipal Advisory Council, I hand delivered a request for an audit to Supervisor Tavaglione because Highgrove was (and still is) paying for a service that is no longer provided. The Deputy's position was established in 1992 with a ballot and again in 1997 with another ballot but none of the parcel owners east of the I-215 freeway received any written notice or another ballot when the Deputy Sheriff that was exclusive to Highgrove was eliminated on Dec. 30, 2009. That was 8 years ago and now each parcel owner is still paying \$120.00 with our property taxes for our Deputy Sheriff that was eliminated.


RENTAL UNITS:

If a Highgrove parcel owner has rental property in Highgrove but lives outside the area in another city for example, where the Highgrove Happenings Newspaper is not accessible, it is possible that the property owner may not even know that the Sheriff was eliminated 8 years

ago. How would the property owner who is responsible for taxes on their rental know about the sheriff if they had not received written notification that the Sheriff's position was eliminated?

WAS ELIMINATING THE HIGHGROVE MUNICIPAL ADVISORY COUNCIL NECESSARY?

It was our honor to have the community room at the new Highgrove Library named after Ardie and me by Supervisor Ashley on March 19, 2011. This plaque is on the wall just inside the entry.



Our monthly community MAC meetings were held at the Highgrove library for 6 years but on April 11, 2017 (8 months ago) Supervisor Tavaglione eliminated the Highgrove MAC at a public hearing and no community meetings are now allowed in the R. A. "Barney" & Ardie Barnett Community Room in the Highgrove Library.

I guess you could say when we

changed Supervisors from Ashley to Supervisor Tavaglione, due to boundary changes, we went from hero to zero!

If Supervisor Tavaglione wants to remove the gold nameplate from the wall with our name on it he probably has the authority to do so. Then maybe a new Highgrove Municipal Advisory Council can be formed without the Barnett name so the collective voice of the community can be heard again through a local Municipal Advisory Council. Municipal Advisory Councils are community organizations that are recognized by the State of California. There was no reason for Supervisor Tavaglione to eliminate the entire Highgrove MAC because the Highgrove MAC did not violate California State Code 31010. (look it up)

Prior to the public hearing that eliminated the Highgrove MAC, I had already resigned from the MAC and ask Supervisor Tavaglione to allow the Highgrove MAC to continue without me.

City of Riverside:

Also, for many years I have delivered copies to the City of Riverside that includes the 7th floor with copies for Mayor Rusty Baily (and previously Ron Loverage), the Riverside City Council members, City Manager and copies are also given to the 3rd and 5th floors at Riverside's city hall. Many County employees and City

employees seem to appreciate our efforts, and want to read about what is happening in Highgrove. And even if they do not read it, I remind them it is serving another purpose because it will fit right in the bottom of their bird cage!

IS LEGAL ACTION NECESSARY?

In November of 2016, the Highgrove MAC submitted 27 questions to Riverside County in order for the county to respond before we obtained the services of an Attorney. Question number 22 asked: **“Will Riverside County refund the taxpayer’s money that was collected after the Highgrove Sheriff’s position was eliminated, or will legal action be necessary?”**

Riverside County’s answer was: **“There was no money in the CSA fund when the designated sheriff was stopped. The assessment collected after that time were kept in the CSA 126 account until enough was built up to provide enhanced sheriff services. No refunds will be issued.”**

The 27 questions submitted to Riverside County from the Highgrove Municipal Advisory Council were published one year ago in the December 2016 issue (pages 5 & 6) of the Highgrove Happenings Newspaper and can be seen on-line by going to: www.highgrovehappenings.net latest issues.

My allegiance is to the Highgrove people. So on behalf of the parcel owners in Highgrove who have paid the \$120.00 assessment after the Sheriff was eliminated, I have given authorization to our Attorney to use my name in initiating legal action against Riverside County, if necessary. Other Highgrove resident property owners have also given written authorization to our Attorney.

If I am offending Riverside County executives in high places such as the Riverside County Supervisor, the head of the Riverside County Sheriff Department, and the head of the Riverside County Economic Development Agency, then they have the right to challenge what I am saying and printing, if it is not true. We need answers from these top administrators because many of these issues may have to be

decided in court. We are confident that the information we print in the Highgrove Happenings is true because it can be verified in writing.

Here is my response to Supervisor Tavaglione’s accusations that the Highgrove MAC Chairman Barnett (yours truly) was: **“going to the Grand Jury to use MAC funds to sue the county”**.

First of all, Supervisor Tavaglione knows that none of the MAC members or former CSA 126 members have ever had any access to MAC funds. The truth is that no money has been spent on an Attorney because our Attorney is addressing these issues on a contingency basis and is now submitting questions to Riverside County.

In regard to the Grand Jury, the answer is yes the Grand Jury is investigating this subject and on Nov. 14, 2017, I testified before the Riverside County Grand Jury committee for 2 hours at their office in Riverside. And no money has been spent for the Grand Jury Investigation from any funds including CSA 126 funds, former MAC funds, or any other funds because no financial payments were required for the Grand Jury to investigate this subject.

The photo below contains written documentation that I took with me to the Grand Jury to show them that I have a paperwork that goes back 25 years to 1992 when the Highgrove Sheriff first started.

Not so Merry news.....

The Spanish Town Heritage Foundation was notified by Council Member Gardner, that the City of Riverside Design Review Committee has approved the proposed 308,000 SF Warehouse at Center and Placentia. We are saddened by this news, but will continue the fight to protect the Trujillo adobe and the Negative impacts on Northside residents.

Council Member Gardner has filed the appeal on our behalf. If Spanish Town were to undertake the appeal, it would have cost us over \$1,500 just in filling fees. This is a huge help and we thank Council Member Gardner for this offer.

Once the appeal is finalized, the Warehouse project will go before the City of Riverside’s Planning

Commission. If the Planning Commission upholds the decision then the project will go to the Riverside City Council and the seven City Councilmen will decide.

We have a battle in front of us and we will need everyone to help. You can help by letter writing, reviewing documents, calling friends and family to help get involved and most importantly attending the meetings.

However, I am flabbergasted to learn that this matter went to the Developmental Review Committee without the knowledge of ANYONE in the Northside Improvement Association, Spanish Town Heritage Foundation or Springbrook Heritage Alliance, as we have been keeping track to make sure the matter did not go to the DRC unnoticed.

I WAS NOT NOTIFIED THAT THE MATTER WAS GOING TO THE DEC. 13TH DRC MEETING.

It would have been sent out at the end of November, two weeks prior to the meeting. I should have received that notice by email as I have been on that list for a long now. If I had received it, I would have read it immediately and shared the agenda if it had anything on it of interest to our Alliance. which interests me because I did receive notices for the Nov. 29th and Dec. 27th DRC meeting.

We are aware, however, that the decision-making process for the Developmental Review Committee has been changed so that staff involved in each case are the ones who make the decision whether to approve or deny an application. This was explained to us at our Nov. 16 SHA meeting by Principal Planner Jay Eastman.

IN MEMORY OF "BIRDIE POWELL"

Nov. 1, 1920 - Nov. 27, 2017

Our Birdie, so much can be said. Birdie has been a residence of Highgrove. There was time when she travelled with her husband Dennis during his time in service but all in all, most of her life was Highgrove. When she returned to Highgrove she and Dennis purchased the house from her brother Bud, and resided there until October 2017.

On October 15, 1992 Birdie joined the Eagles Auxiliary, Riverside Aerie #997. She immediately was assigned St. Patty's Day. Birdie had made a promise to Dottie DeVille, that if something happened to her, she would take over this charity as Dottie always did it for the City of Hope. Dottie passed away on July 29th, 1992 so Birdie was prepared to do whatever she could for her friend. Birdie would work very hard to get donations so that all the money received would go to the City of Hope. To date, Birdie has donated approximately \$30,000 to the City of Hope. Dottie would have been so proud.

Birdie was asked by Dave Jackson to help with Monday Night Taco's. Birdie agreed, and she continued to do them for over 25 years. Dave passed away in 2008 and Birdie decided to continue doing tacos in Dave's honor. All proceeds went to the "Dave Jackson Memorial Fund." In doing her taco's Birdie became good friends with everyone. Many jokes and lots of fun came from Birdie's quick wit. Birdie really appreciated the support from everyone. Eagle members, not only supported the Tacos, but they always



supported her City of Hope fund raiser. Birdie would always get everyone to feel sorry that she didn't have all the money for her meat. It always worked, and she never had to pay for anything from the proceeds. You couldn't help but love Birdie. Some of the important times in Birdie's life as an Eagles besides being Madam President was being chosen as "lil Sis" for Frenchy DeVille who had become our State Worthy President. Dennis became Frenchy's "Father". This was quite an honor for both of them.

Birdie continued to go through the chairs, and in 1996-97 she became Riverside Auxiliary Madam President. Birdie was active not only in the local Auxiliary but she belonged to District #23 and helped at State Convention for quite a few years. She also attended many Mid-Winter Conferences. Birdie received the District Hall of Fame, Carol Bennett Ward, and in 2008 Birdie received the "State Hall of Fame Award".

Birdie was quite talented. She crocheted Slippers, Afghans, and made

the most beautiful dolls. She enjoyed giving them away, and usually just before Convention those who were going to Convention would receive a "shoe bag". I have used mine a lot.

We can't forget Birdie's Friday Night Dinners". This was when the kitchen became "Birdie's Kitchen". I worked with Birdie almost 21 years, and Birdie loved her job. Every week, faithfully Birdie and I would go shopping. We would come back, set up the kitchen and "ready to go the next day" Birdie had a "great sense of Humor" and sometimes when you least expected it, she would hit you with a good one. Birdie had that "quick wit" until the end.

Birdie loved the Eagles, she loved her kitchen, she loved giving to City of Hope, and she loved everyone. This was Birdie's life, and she missed it at the end. This kitchen should always be "Birdie's Kitchen" in her memory. She made a lot of money, not only for City of Hope and Dave's Memorial Fund, but for the Aerie. Dennis would be proud of her achievements, and I am sure he has already told her.

To her daughter Betty, and all of her family we thank you for Birdie. We give you our sympathy, but we also know that Birdie has lived a good life. She lived 97 good years, and we were fortunate to celebrate many of these years as Eagles with Birdie.

Birdie, I speak on behalf of everyone who knew you. We love you. Till we meet again. Rest in peace Birdie.

80 acres east of I-215 to be developed in Grand Terrace



The photo above was taken when the 3 railroad bridges were constructed to span the widened 215 freeway a few years ago. This was the south end of Commerce Way that will be extended southward to the San Bernardino/Riverside county Line at Main St. in Highgrove.

On December 8, 2017 the Lewis Group submitted the "Gateway" Specific Plan. The Specific Plan will provide an opportunity for the City to Master Plan over 80 acres adjacent to the I-215 freeway from Main St. in Highgrove to Commerce Way in Grand Terrace.

The Gateway project proposes residential, commercial and public land uses, and is expected to have an assessed value of \$400,000,000 at

build out. The project will help alleviate historical infrastructure issues that exist in Grand Terrace, through the expansion of Commerce Way to Main St. while also addressing storm water drainage issues. The process is just beginning; there will be a number of opportunities for stakeholders and community members to participate in the process.

Dead tree poses possibility of 2nd fire!

Dear Editors, Highgrove Happenings:

I have a story that may be of interest regarding Southern Cal Edison's disinterest in damage caused by what I consider to be in their sphere of responsibility. It may not be worthy of a place in your newspaper, but I will relate it to you and submit a picture.

I live at 136 E. Main Street and on April 8th of this year my neighbor to the east of me was having his tree in his front yard trimmed. The trimmers cut a limb that fell on Edison's power lines and broke 4 of the power lines. Some of the lines fell in my yard and burned a groove through my grass which grew back in time and didn't cause any lasting problem.

The problem that I am reporting occurred on the property of the neighbor just west of me when the broken wires fell and set their power pole and the tree next to it on fire. The Edison crew was on the job and extinguished the fire, repaired their broken wires, and left.



This tree has been dead since April 8, 2017 according to Mr. Hazelrigg. How would you like to have to look at this dead tree for almost 9 months? The dead dry limbs are another fire hazzard during our recent fire season.

The tree died because of the damage done by the fire. I suggested to the owner of the property where the tree is that she contact Edison and ask them to send their crew to remove the tree since the fire resulting from their fallen wires killed it. She never did call them so I called in her stead and a crew or member of their crew came and looked at the tree and determined that since the dead tree limbs were not in their wires that it wasn't their responsibility to remove the tree.

I called and lodged a complaint with someone at Edison and the contact there confirmed that the criteria for Edison to trim or remove a tree was that if the tree was in their wires.

I reminded Edison that their fallen wires caused the fire that killed the tree and the tree is possibly a hazard to my property and the neighbor's property just west of me since it is very close to both of our driveways.

Since they have a crew that does tree trimming and removal, and the fire caused by their fallen wires killed the tree, I was hopeful that they would remove the tree for safety's sake and to accommodate their customers.

I am disappointed by their refusal.

Enclosed is a picture of the tree and pole that was damaged by the fire.



HIGHGROVE HAPPENINGS

Growing up in Highgrove!

Our family was from Ft. Wayne, Indiana but in 1947 we sold everything, my dad bought a new Chevrolet and a 26 ft. Liberty trailer, and we moved to Highgrove due to my mother's health. She almost died from allergies to rag weed in Indiana. Mom and Dad, my 2 brothers and me and the cat, headed west to California on Route 66. We stayed in the Aloha trailer park on West La Cadena and later at the Anderson's trailer park north of Pitruzzellos for 18 months. My mother was fine living in this climate so maybe you can imagine what it was like when we bought the house on Prospect and our family of 5 people moved into a house that was much bigger than a single wide trailer. I was 8 years old at the time. Mom out-lived Dad by 16 years. Here is what it was like to live in Highgrove over 70 years ago! At that time there was an orange grove across the street and an orange grove behind us between the Pacific Electric R R tracks (before the SPRR & UPRR) and the school.

In fact there were orange groves all over the place and there was another packing house that burned down on the north side of Center St. between Transit Ave. and the Santa Fe RR tracks. Across Center St. on the south side was the Highgrove Santa Fe RR depot that had a "No bicycle riding sign on platform" that I used to violate when the Agent was not around. The Agent, the late Bruce Easton and I later became friends and several years ago he gave me a scale model of the Highgrove Depot that he made that I cherish. Back then we knew almost everyone on our street. From the United Methodist Church southward at the corner of Prospect and Fountain was Charlie and Bea Walters. Their Grandsons Wayne and Larry Walters lived at the east end of Fountain St. with their Mom and Dad. Years ago Larry was killed while on duty as a police officer but Wayne and I are still good friends. Wayne lives in Riverside. Next to Charlie and Bea Walters

was the Teats and Gladis Twogood family. Ther son Theron and his wife have lived in Utah for many years. Continuing southward on the east side of Prospect were the Collins family, Price family, Bowers, Criswells, Clarks on the north side next to us and the Bush family on the south side. In the next block south of Spring St. was where Bert McNutt and Margaret lived with their sons Neil and Steven. The McNutts were the first family in Highgrove to have a television set and all the neighbors would go to their small 2 story house to watch the Lone Ranger and drink Vernors soda. Across the street from the McNutts was where the Gero family lived and once I had a head-on collision with Robert Gero on our bicycles in front of Dan and Avis' house. Also on the west side of Prospect was the Cormier family, Firestone family and at the S/W corner was the Lunderman family. The next block northward was an orange grove owned by Tom Hawthorn who owned a Ford Tractor that he used, to plow between the orange trees for weed control. He was very old back then and as the story goes when he went to by his tractor none of the salesmen wanted to go talk to him because he looked so scroungy. When he finally was

approached he paid cash. Back then when we would go trick-or-treating at Hollween you would only get a couple of jelly beans at his house on the west side of Spring and Transit. He chewed tabacco and dried his chew out on the cup shelf along the wall for later use. The next block southward on Prospect was the Mitchells house on the corner of Villa and Prospect and once I found my bicycle up on a telephone pole by their house. I never found out who put it up there! Then there was the Spiker house and Dan and Avis Hogans then the Delmonts and on the N/W corner of Fountain and Prospect was the Taylors. Denis Kidd and his parents lived across the street from the church. Ben & Bessie owned Bens Place where you could get a root beer for 5 cents or a big one for 10 cents but we wern't allowed in the back room where the pool table was located. Yes I enjoyed growing up in Highgrove and I have seen a lot of changes. There were 12 of us who were the last 8th grade class who graduated from the Highgrove Elementary School in 1953 but most of them are gone now. Highgrove has always been my home town and maybe they will find orange juice in my veins when I am laid to rest. Some people say I never grew up but I just got older!

HERO BUS DRIVERS RESCUE CHILDREN FROM CRASHED CAR

Three RTA coach operators, a security manager and a contractor are being praised for their vigilance on December 4 when they assisted with the rescue of a family trapped in a car that had crashed near RTA headquarters, an action that reflects their loyal service, bravery and commitment to helping those in need. On that day, coach operators Octavio Davila, Tanya McFail and Odis Session, Safety and Security Manager Richard Ray and contractor Ray Lum, rushed to the scene of an accident just seconds after it occurred at the intersection of Third Street and Anderson Avenue.

The black Ford Expedition had collided with the curb and rammed into telecommunication boxes on the roadside. Inside the crushed vehicle were three children and two adults. Before police and fire arrived to the scene, these individuals reached inside the broken windows and shattered glass to pull three children out of their car seats and to safety. They also assisted with the adults until help could arrive. The five occupants were transported to local hospitals, one with serious injuries. On Thursday, the RTA Board of Directors honored Davila, McFail, Session, Ray and Lum with hero awards for their actions.

Route and Schedule Changes Coming in January

On January 14, RTA will introduce new CommuterLink Route 200 with service connecting San Bernardino, Riverside and the Disney resort in Anaheim as well as Route 205 between Temecula, Lake Elsinore, Corona, and the Village at Orange. Also, get ready for faster service aboard Route 19 which will begin serving stops every 15 minutes. Plus, RTA will launch a spectrum of schedule changes to improve service frequency, reliability, on-time performance, and connections. Holiday Schedule

On Christmas Day and New Year's Day, RTA will provide Sunday service. The Customer Information Center will be open and administrative offices will be closed. On December 22 and 29, RTA will provide regular service and administrative offices will close at noon.

Free Rides on New Year's Eve

On New Year's Eve, December 31, RTA will offer free rides to passengers after 2:30 p.m. on all fixed-routes. It's our way of providing a safe transportation alternative during the holiday and saying thank you to our customers for their year-round patronage.

Avila Elected Vice Chair of Omnitrans Board

Council Member David Avila was elected Vice Chair of the Omnitrans Board of Directors at the transit agency's December 6 meeting. He fills a vacancy created when Redlands Council Pat Gilbreath passed away in October.

Avila's term as Vice Chair will run through June 2019. Traditionally, the Vice Chair subsequently assumes the Board Chair position for a two-year term. The Omnitrans Board consists of elected officials representing each of the 15 cities Omnitrans serves and four San Bernardino County Supervisors. The current Chair is Loma Linda Council Member Ron Dailey.

"There are too many cars on the road. We need to make public transit a more viable alternative," said Avila. "I look forward to working with Omnitrans to help implement faster and more streamlined services to attract new riders."

Avila joined the Omnitrans Board



in January 2017, and has served on the Board's Administrative & Finance Committee. He also represents Yucaipa on the San Bernardino County Transportation Authority Board of Directors.

A 30-year resident of Yucaipa, Avila has served on the City Council since 2014. He had a 32-year career with Cal Fire (California Department of Forestry and Fire Protection) before retiring as a battalion chief.

He received his Associate of Science degree from Crafton Hills College and earned a BA at California State University, Fullerton. Avila said he used public transit often while a student at CSUF.


