## Highgrove Sheriff eliminated years ago but Assessments still goes on!!!

Every Highgrove property owner east of the freeway should read this article!

We still see the Sheriff car driving around in Highgrove but did you know that it is not the dedicated Highgrove Sheriff position that was approved by voters back in 1991, 1992, and re-affirmed in 1997? About 10 different Sheriff Deputies have filled that position during the last 25 years but the Sheriff Deputy that was exclusive to CSA 126E in Highgrove was eliminated several years ago. Today we are still paying \$120.00 per year, per parcel that appears on our property tax bills for the Sheriff position that we no longer have! If we do not pay our property taxes in full, our taxes will become delinquent and a lien could be put on the properties that do not pay.

We still have regular Sheriff coverage in Highgrove similar to the rest of Riverside County but previously, when we had our own Highgrove Deputy assigned exclusively to Highgrove, the Deputy got to know the people who belonged here and those who did not! The extra Highgrove Deputy was assigned exclusively to the east side of the freeway and was in addition to the regular Sheriff coverage everybody else in Riverside County is entitled to. We assessed ourselves for our own Deputy and the Riverside County Sheriff Department assigned one of their Deputies to Highgrove for about a year at a time to cover the small 3 1/2 square mile area east of the freeway. As an unincorporated community in Riverside County, Highgrove is entitled to 1.04 Deputies per thousand residents without the additional Sheriff

coverage.

The population of Highgrove on both sides is approximately 4,000 people, not including Spring Mountain Ranch.

Back in 1991, Highgrove was the first unincorporated community in Riverside County to authorize a self-imposed annual assessment of \$120.00 per parcel to pay for an extra Sheriff Deputy on the east side of the freeway. This worked well for many years but when the Highgrove Sheriff position was eliminated, none of the parcel owners were given written notice. Taxpayers still have not received written notice from the Riverside County Assessor, Riverside County Board of Supervisors, or the Riverside County Sheriff Department that the dedicated Highgrove Sheriff position was eliminated but the assessment is still being collected to pay for the Sheriff that we no longer have!

When the position was eliminated, the voters should have been given the opportunity to vote again. Three possible choices come to mind for the voters to decide:

1. Eliminate the \$120.00 fee and the extra Highgrove Sheriff position.
2. Vote for an increase in parcel fee to cover the increased cost of the Highgrove Sheriff.
3. Reduce the amount of hours of the Highgrove Sheriff so we can stay within our budget.

Unfortunately none of these choices were offered to the voters. The Highgrove Sheriff was created and approved in writing by the voters in 1992 and again in 1997 by a ballot of the people, by the people and for the people who pay the assessment. Eliminating the Sheriff position without proper written notification to those who pay the assessment is not only unfair but is probably also illegal. We are being taxed for something we do not have which some people feel is "Taxation without Representation".

A copy of the Feb. 21, 1992 ballot stated: ***"The need for extended police protection will be decided with this ballot"***. It said nothing about Park Maintenance, Landscaping, or Recreation which was added later because there was no park at that time. The 1992 ballot can be seen on page 12. (Cont. on right)

### Potential Income denied!

The new parcels in the Spring Mountain Ranch development consists of 1,409 new homes that used to be citrus groves. All of the new Spring Mountain Ranch homes are within the CSA 126E boundaries but the new homes are not paying the \$120.00 assessment. Other members of our community have been paying \$120.00 per year for 25 years for each parcel whether it is residential, business property, or vacant land and we depended on the new Spring Mountain Ranch parcels to help pay for our Highgrove Sheriff.

1,409 new parcels in Spring Mountain Ranch at \$120.00 per parcel would be annual income of \$169,080.00 that would help pay for the Highgrove Deputy to serve all of the existing residents in Highgrove plus the new homes in Spring Mountain Ranch. The \$169,080.00 is addition to the amount being collected from the old part of Highgrove.

On April 13, 2016 I received a reply from the Riverside County Auditor-Controller's Office about my request for the numbers of parcels paying the Sheriff Assessment

and the amount collected for the last several years.

Here is the information I received from the Auditor's office:

The last figure (2015-16) increased by over \$518 Thousand dollars and none of that figure includes sheriff services? And the CSAE designation has been changed on our tax bills that now shows CSA 126, PARK & REC LNDSCPE. Remember the original ballot was for additional Sheriff protection as shown on page 12. From 2008-09 to 2014-15 the auditor's figures show that \$929,850.00 has been collected for Highgrove account # CSA 126E. But the Sheriff Dept. and the County do not know when the last day the Highgrove's Deputy was on duty. The fee should have stopped the day after the Sheriff was eliminated.



## Tips on how to protect your mail

Comments from Lieutenant Kondrit about mailbox theft:

"Unfortunately this is more common than ever. Eastvale had 55 separate incidents. When we caught our suspect they still had an entire mailbox in their apartment. That suspect admitted to making a living stealing mail. Here are some recommendations to prevent and minimize the impact of mail theft:"

- Use the letter slots inside your Post Office for your mail, or hand it to a letter carrier.
- Pick up your mail promptly after delivery. Don't leave it in your mailbox overnight. If you're expecting checks, credit cards, or other negotiable items, ask a trusted friend or neighbor to pick up your mail.
- If you don't receive a check or other valuable mail you're expecting, contact the issuing agency immediately.
- If you change your address, immediately notify your Post Office and anyone with whom you do business via the mail.
- Don't send cash in the mail.
- Tell your Post Office when you'll be out of town, so they can hold your mail until you return.
- Report all suspected mail theft to a Postal Inspector.
- Consider starting a neighborhood watch program. By exchanging work and vacation schedules with trusted friends and neighbors, you can watch each other's mailboxes (as well as homes).
- Consult with your local Postmaster for the most up-to-date regulations on mailboxes, including the availability of locked centralized or curbside mailboxes.
- If you see a mail thief at work, call **911**. Or if you believe your mail was stolen, call the (Non-Emergency) number **(951) 776 1099** immediately, then call Postal Inspectors at **877-876-2455** and press 3.







## Parcel Fee Cont. from P. 1

And who made the new homes in Spring Mountain Ranch exempt from the CSA 126E fees? These fees were in place many years before any of the new homes were built! Remember the 1997 ballot said: “**all parcels in CSA 126 Zone A**” should pay the special tax!

If almost one million dollars have been collected from Highgrove taxpayers for the last several years to pay for our own Highgrove Deputy Sheriff that we did not have, then why did page 2 of the Jan. 12, 2016 audit only show a balance of \$287,455 at the end of the fiscal year 2014/2015? Where did all of the money go?

Also needed is an explanation why the landscaping costs went from \$37,482 in 12/13 then jumped to \$163,992.

What could possibly require an increase of \$126,510.00 for park maintenance? We only have one park! The audit states: “**This was primarily due to additional funds being spent for landscaping (\$100K more than normal) and an additional 100K being spent on park maintenance**”.

Page 1 of the audit refers to the CSA staff: “**Their primary responsibilities are landscape maintenance of orange groves at Highway 215 and Center Street, medians at Iowa and Center Street, Graffiti removal and reporting street light outages**”.

Page 9 has color photos of the medians, graffiti, and pictures of

the Highgrove Community Park.

This problem has gone on too long and our 2015/2016 tax bills still show the assessment on our properties to be \$120.00 per year. But now instead of stating it is for **CSA 126E** like in the past, the assessment now states it is for: **CSA 126, PARK & REC LANDSCAPE**. Check your tax bills and go back several years.

How can these fees be changed and diverted into Park & Recreation Landscaping when the original intent was for an additional Sheriff Deputy in Highgrove? (See Page 12)

Several suggestions have been made that include a refund of all of the money that has been collected starting on the day after we lost our designated Highgrove Sheriff, a lawsuit, a Grand Jury Investigation, or going to the Press-Enterprise, or Television investigative reporters.

Another possible solution may resolve this problem:

The Sheriff Dept. and County owe the existing part of Highgrove (CSA 126E) several years of service they have already paid for but didn't receive. On the other hand, the new Spring Mountain Ranch homes are also within CSA 126E, but they have not paid anything into the fund to pay for the extra Sheriff.

The \$120.00 annual fee should be stopped after the 2015/2016 fiscal year on the existing properties that have already paid the fees!

Starting in the 2016/2017 fiscal year the Spring Mountain Ranch homes, and any other new future parcels that are created after this agreement, should be required to pay into the Highgrove Sheriff fund until the equivalent amount of revenue is reached that their Highgrove neighbors have paid.

Example:

Using the assessor's figures:

Between 2008 and 2015 the existing parcels in Highgrove CSA 126E have already paid a total of \$929,850.00 and these fees should stop. Then an assessment should be levied on the new parcels in Spring Mountain Ranch and other future developments that have not paid into the fund. These parcels would be required to pay \$120.00 per parcel per year until the equivalent amount of \$929,850.00 is paid into the Highgrove CSA 126E Sheriff fund.

This would balance the scales of justice because the existing parcels have been charged too much and the new parcels have not been charge anything.

On the date of this agreement the existing hourly rate for a Sheriff Deputy would be used to determine the amount that Spring Mountain Ranch or any other new parcels would be charged the assessment.

The present rate for the fiscal year 2015/2016 according to the Riverside County Sheriff Dept. is currently \$127.60 per hour. (Based on 40 hours per week the annual

cost is \$265,408.00). But the rate will increase for the 2016/2017 fiscal year to \$137.14 per hour which amounts to an increase of \$19,843.20 meaning the 2016/2017 annual cost will be **\$285,251.20** using these figures. All of the parcels in CSA 126E would then have a Sheriff Deputy that would include the old part of Highgrove, Spring Mountain Ranch, and any other new developments.

After the new parcels have paid the same amount as the old part of CSA 126E, another vote could be taken to eliminate the assessment, increase the assessment, reduce the assessment, increase the Sheriff coverage or reduce the Sheriff coverage.

During this equalization period, if the City of Riverside decides to consider annexing Highgrove, the annexation should be postponed until this local issue is resolved.

RUBIES AND SAPPHIRES: gem varieties of CORUNDUM

The last few articles have discussed many of the minerals and gems found in pegmatites on the southern side of the San Jacinto Mountains (SJM) within the Southern California Batholith (SCB; fig. 1). The northwestern and western sides of those mountains contain other gems, notably rubies and sapphires,

which are the gem varieties of corundum, generally a dull-colored aluminum oxide mineral that is used in abrasives, mostly emery, because of its extreme hardness.

Corundum is one of the hardest natural materials (Mohs hardness 9), second only to diamond (Mohs hardness 10) and moissanite, a rare silicon carbide (Mohs hardness 9.25). The crystal form of corundum is trigonal, like tourmaline, both of which are in the hexagonal family


The median in the parking lot at the Norton Younglove Community Center has no vegetation that requires maintenance.



This BAR-B-Q area has not been properly maintained and needs weeding. The annual assessment of \$120.00 per parcel has been shown on our property tax bills for many years as: CSA 126E. But this was changed this year on our tax bills to: CSA 126, PARK & REC LNDSCE.

From 2008 to 2015 the amount shown collected by the auditor averaged \$132,835.71 but this year shows \$651,592.46 which is an increase of \$518,738.75 that has been collected for park fees that does not include any money collected for the Highgrove Sheriff position that was eliminated.

This graffiti was painted over by the business owner for the 2nd time in 2 months because Riverside County no longer paints over graffiti on private property. The audit states the EDA is responsible for its removal but it has been transferred to the property owner or business owner to paint over.



The following statement was taken from the audit we received from the county:

**"On the expenditure side, the expenditures for FY 12-13 and FY 13-14 were in the \$200K range, with FY 14-15 showing a dramatic increase to \$388K. This was primarily due to additional funds being spent for landscaping (\$100K more than normal) and an additional \$100K being spent on park maintenance"**

The Park & Recreation/Landscaping costs increased by \$518,738.75 last year. The vegetation has not been replaced with drought tolerant landscaping like mentioned in the audit and there is no more Pony Baseball or other programs in our park. We only have one park and for that price we should have shrubs without holes and trails paved with gold!

of crystals. As discussed further on, the trigonal nature of corundum allows the formation of the luminous star seen in crystals that have been properly ground and polished to form star rubies and star sapphires. Corundum occurs in many geological environments, but those within the SJM are found within pods of metamorphosed aluminum-rich sedimentary rocks (mostly mica schist) within the granitic rocks of the SCB. These pods are remnants of older rocks that were intruded by the molten batholith, as discussed in an earlier article. Another source of corundum in Southern California is in the San Gabriel Mountains near Mount Baldy.

Common corundum is rather dull looking, mostly gray or brown and, in some localities, coated with mica. Some of the SJM corundums have clear or blue cores, but most are not suitable for lapidary purposes. The crystals are commonly elongate with tapered ends and can grow to more than 6 inches long and 2 inches in diameter. They have fractures perpendicular to the long axis (called basal parting, fig. 2), much like tourmaline. Some corundum crystals are completely translucent and form rubies or sapphires.

Corundum was discovered on the northwestern side of the SJM within a couple of miles of the Potrero shaft entrance of the Metropolitan Water District aqueduct system near Cabazon in San Geronio Pass around 1924 (Mindat.org, <http://www.mindat.org/loc-3526.html>). The area was visited again in 1939 and later mined at times since 1980. One of the most celebrated deposits is called the Mt. Edna site, reportedly near the earlier exposures of corundum-bearing deposits, although its location is a secret. The SJM corundum localities are mostly at exposures of eroded hillside debris in which loose crystals can be found. Other localities lie on the western side of the SJM at Cahuilla (Coahuila) Mountain and on a hill near Winchester, on the Hemet plain (fig. 1). These western deposits are within pegmatites that also yield abundant andalusite, an aluminum silicate that has a transparent gem variety; this gem has not been reported from Winchester, however.

Red corundum of gem quality is called ruby; the blue variety is called sapphire, and clear crystals are called white sapphires. The clear variety is occasionally substituted for diamonds. Crystals of other colors are generally lumped together as sapphires. A rare, pinkish-orange variety is called padparadsha.

The trigonal crystal structure of corundum and, thus, of rubies and sapphires, allows needle-like inclusions of minerals, such as rutile, to align into a three-plane orientation parallel to the long axis. This crystal structure channels light into a six-pointed star (fig. 3). Crystals of rubies and sapphires containing rutile needles that are aligned with the long axis are generally cut and polished to a rounded upper surface with a flat bottom (called en cabochon cut, as opposed to facets). Orienting the polished, rounded upper surface perpendicular to the long axis produces a six-pointed star of focused light, whereas orienting the rounded upper surface parallel to the long axis may produce a "cats-eye" or "tigers eye" effect rather than a star (fig. 3). Unlike other gems with inclusions, rutile needles in rubies and sapphires attest to the gems' authenticity as natural specimens because synthetic versions do not contain these inclusions, although many specimens of rubies have had their color artificially enhanced by heat treatment.

Rubies are the birthstone for July, and sapphires are the birthstone for September. Rubies derive their red color from chromium ions in the crystal structure (not the rutile inclusions); blue sapphires derive their color from iron and titanium ions. Aside from their use in jewelry, rubies are used commercially in ruby lasers, and sapphires are used in optical components, wrist-watch crystals, movement bearings, and solid-state electronics.

In addition to rubies and sapphires, the SCB yields a variety of other rare and unusual gems, including topaz and tourmaline (see February and April issues) and kunzite, a pink spodumene. At the northeastern edge of the SCB lie the Crestmore quarries at Jurupa Valley (fig. 1), with a multitude of rare minerals found in their marbles. A future article will discuss this unusual area and its mineral varieties.



# HIGHGROVE HAPPENINGS

## History of Highgrove Deputy Sheriff!

Here is the timeline!

**Aug. 27, 1991:** CSA 126 (Highgrove East) minutes state that: *"The Sheriff's Department will pick and assign an officer to the Highgrove area by 9-1-91 and will work out of the local substation, and will meet monthly with the Highgrove police protection subcommittee group"*.

**Feb. 21, 1992:** Mail out ballot stated: *"The need for extended police protection will be decided with this ballot"*.

There was no mention for any of these funds going to Park Maintenance or Landscaping because there was no park at this time.

**Feb. 25, 1992:** Results of the vote were sent in writing to the Riverside County Administration Office verifying that voters *"voted to retain the police protection provided thru contracting with the Riverside County Sheriff's dept."*

**Spring 1994** issue of Highgrove Happenings: Rate of \$100.00 considered but remained at \$120.00 per year to use the surplus funds to hire an additional Deputy. *"The extra deputy will work the two days per week when our present deputy is off, giving us a deputy eight hours per day, seven days a week"*.

**Spring 1995** issue of Highgrove Happenings: announced a meeting on March 27, 1995 calling for expanding Highgrove Sheriff service to the West side of CSA 126. *"Presently the additional coverage is only on the east side. This meeting is important and it will enable you to decide whether or not you want this additional protection"*. The west side did not want the additional Sheriff coverage.

**Feb. 1997:** Copy of Vote Yes flyer showing comments about a future park in Highgrove. *"We'll build it if you maintain it has been the policy of the Economic Development Agency in regard to our Community Center and Park"*

**Feb 1997** issue of Highgrove Happenings: article about a future park in Highgrove and *Proposition 218*.

**March 1997** issue of Highgrove Happenings headline: *\$120.00 annual assessment to be decided by Highgrove Voters*

**July 1997** issue of Highgrove Happenings: A new ballot was required before distribution due to west side of CSA 126 not participating. *"The election should only include registered voters from the east side of CSA 126. However, the west side was mistakenly included as well. This required action to correct the problem by only allowing the registered voters on the east side to vote on the measure"*.

**July 1997:** Impartial analysis of *Measure "T"*

Copy of actual ballot showing: **ALL PARCELS WITHIN CSA 126 ZONE A**

(Zone A is east of the I-215 freeway)

**August 1997** issue of Highgrove Happenings headline: *Highgrove Measure "T" passes by 75.8 %*

**Nov. 1997** issue of Highgrove Happenings: *Article by Highgrove Deputy Matt Cosgrove and Deputy Patty Ortiz about street gangs.*

**April 1999** issue of Highgrove Happenings: *Article by Highgrove Deputy Matt Cosgrove about crime sweep*

**April 22, 2015:** On my birthday, 3 of the Highgrove Municipal Advisory Council members went to Supervisor Tavaglione's office for a meeting. There were 11 people at the meeting that included Supervisor Tavaglione, Captain Jason Horton of the Sheriff Department, other members of the County, and the Sheriff Department.

I laid out a 3 ft. by 5 ft. color aerial photograph on the table showing an overhead view of the Highgrove area. I pointed out that the blue line at the top was the San Bernardino/Riverside County Line and the red line at the bottom was the City of Riverside's boundary line. *All of the property between the blue line and red line, which includes all of the new homes in Spring Mountain Ranch, is within the CSA 126E known as Highgrove.* Shortly thereafter Supervisor Tavaglione had to leave for a dental appointment and missed part of the meeting.

**August 5, 2015:** *Audit hand delivered to Supervisor Tavaglione at Board of Supervisors office by R. A. Barnett, Chmn. Highgrove Municipal Advisory Council.*

**January 7, 2016:** Captain Jason Horton, Riverside Sheriff Dept. Jurupa Valley Station answered request from MAC Chmn. Barnett asking when the last day was that Sheriff Deputy Dean Colbert was assigned to Highgrove?

Captain Horton's reply was: *"the answer to your question is not exact, but the last full year was 2008 with a partial portion of 2009 according to my records. I don't know the date of his last day"*

**January 12, 2016:** *Audit received from County of Riverside that did not include many items requested.*

**February 17, 2016:** Information received from Special District Financing that *"the total number of parcels levied for fiscal year 2015-2016 were 1,337."*

**March 7, 2016:** *Meeting scheduled by Supervisor Tavaglione's schedule maker Lilliana but Supervisor Tavaglione never attended.* Two of our MAC members

took off work to attend but instead of meeting with Supervisor Tavaglione we met with his Chief of Staff, John Field and Jason Farin.

**March 7, 2016:** Chmn. of Highgrove MAC, R. A. Barnett *sent e-mail to Supervisor Tavaglione about missing him at the meeting and requested an Op-Ed from him for our April Issue like we talked about last October.*

*As of April 28, 2016, over 7 weeks later, no Op-Ed has been received.*

**March 9, 2016:** Chmn. Barnett requested that: *"Ways to solve CSA P126E parcel assessment"* be put on MAC agenda for March 16, 2016 Highgrove MAC meeting. The CSA 126E audit was discussed under old business.

**March 17, 2016:** Chmn. Barnett called Lilliana and ask for another meeting with Supervisor Tavaglione but *Supervisor Tavaglione decided another meeting was not necessary* because Mr. Field and Mr. Farin told him about the meeting he missed on March 7, 2016. Barnett's e-mail to Supervisor Tavaglione that afternoon stated in part: *"Please read the information in the March issue of the Highgrove Happenings about this subject and give this subject the priority it deserves"*.

**March 2016** issue of Highgrove Happenings contained: *Copy of audit* that was given to Supervisor Tavaglione on Aug. 5, 2015 on pages 1 and 4, Chmn. *Barnett's letter responding to audit* received from Riverside County on pages 4 & 5. Copies of Barnett's letter also sent

to each MAC member; Supervisor Tavaglione; Sheriff Captain Jason Horton and Lieutenant Kondrit; Bill Brown, Riverside County Economic Development Agency, and Samuel Wong Senior Management Analyst Riverside County Executive Office.

On page 5 is a *list of 10 Sheriff Deputies* who were assigned to Highgrove from 1991 to ??? and also is a copy of the *request that was made before the 1997 ballots were printed* so the vote on the SUPPLEMENTAL SHERIFF PROTECTION and MAINTENANCE OF FUTURE PARK could be voted on separately.

This separation was denied by the County and a *copy of the 1997 ballot that combined these 2 items* is also shown on page 5 showing that the *Sheriff and Park & Recreation Services were combined on one ballot.*

On page 7 is an article titled: *One three letter word can make a big difference.* That word is "ALL" referring to "all parcels within CSA 126 Zone A".

*Zone A is all parcels east of the I-215 freeway* in the unincorporated part of Riverside County between the Riverside/San Bernardino County Line on the north, and the city limits of the city of Riverside on the south.

## California Dreaming

May is upon us. Thank goodness! That means I survived another winter, which admittedly, was milder and shorter than usual. We were given a nice load of snow which was seriously needed and now the warmer weather is rolling in. I'll get to start my very modest garden in a few weeks; our property is blessed with many ponderosa pines which is a lovely environment but makes it sun-challenged. Growing anything other than a handful of herbs is an exercise in frustration.

Mother's Day is coming. I am a great-grandmother (OMG!), grandmother and mother. I find myself thinking about my grandmother, Momo, as a great-great grandmother and my mom when she was a great grandmother. Mom was the mother to eight and grandmother and great-grandmother to a big bundle of offspring. I'd like to tell you about my mom.

Born September 27, 1928 in Shamrock, Texas, Hughee Marie Hogan was a beauty, known for her dark curly hair, long slender legs and beautiful features. She grew up during the depression, living on the family ranch in Wheeler, in the panhandle of Texas. Eventually the family moved to Brownsville, Texas. At the end of WW II she started working for the phone company and then took a job in Hawaii for the military as a phone operator. She fell in love with the exotic location, a love that was to last the rest of her life. I remember her telling me she was so homesick- for Mexican food. She asked her mom to send her a care package of canned chilies, sauce and even canned corn tortillas.

When she left Hawaii she started working for Pacific Bell in Riverside as a switchboard operator. Her mom and sister moved from Texas and joined her at the phone company. The three of them had a great

time working and playing. They were very popular and had a great time with the social scene in Riverside in the late 1940's. They hit the clubs, dancing and partying, where my mom earned the nickname "Legs" because of her long, slim, shapely legs and she was a fabulous dancer. Along the way she met a suave, handsome US Air Force lieutenant stationed at March AFB. They danced, they fell in love and then she married Ernest "Bud" Williams in March 1952.

After Dad finished his Air Force tour they settled again in Riverside. By then I had come along and after that seven more kids within ten years. After the fourth child we moved to Highgrove. Mom had to use all her resources and talents to keep us all fed, clean and clothed.

Mom was an incredibly creative and talented woman. She could sew, crochet, knit, embroider, and did amazing things with craft materials. She made most of our dresses, shorts, tops, sun suits and pajamas. Halloween was a busy time making costumes for us kids. A few times she made costumes for Dad and herself and they were always outstanding and people raved over them. She sewed my wedding dress, a stunning number of white velvet. She learned how to do cake decorating and after that birthdays were even more special. She made nearly everyone's wedding cakes (some more than one...), anniversary cakes and baby shower cakes. They were beautiful and very professional looking. Dad was a supervisor at both of his jobs and being on a tight budget, Mom created the most darling gifts for the employees. Each Christmas they eagerly looked forward to seeing what she had for them. One creation particularly sticks in my mind. She made the most adorable Santas from old-fashioned glass chimneys. The base was a circle of styrofoam covered with red felt; Santa's eyes, nose and cherry mouth were felt glued on the

chimney and perched on top was a red hat with fur trim. The inside of this cute creation was filled with peppermint candies. She also crafted little bazaar items to make a little extra money. I remember crocheted poodles to cover nail polish bottles and swans made from netting and beads covering bars of soap. She was very busy as they were in high demand.

When most of the kids were out of high school Mom went to work for the US Census Bureau. She started as a typical census taker, visiting homes and gathering data. Later she started working full-time for the bureau, gathering information for many different types of surveys. She spent a lot of time at hospitals reviewing medical records, driving in remote areas surveying housing, and visiting homes doing health surveys. She frequently traveled to her beloved Hawaii and drove all over Southern California. After Dad retired from UCR he was

her road partner and they were a tight pair. After he died, very unexpectedly, it was work that gave her a sense of purpose and helped her go forward. Mom was highly regarded for her high level of excellence and her charming personality; she received many awards for outstanding service to the U.S. Census Bureau and made a trip to Washington, DC to receive a top award.

Mom was a remarkable, lovely, engaging woman. She was a treasured wife and an amazing mother. We were all devoted to her and we miss her dearly. Mother's Day is a bit less without her.
