



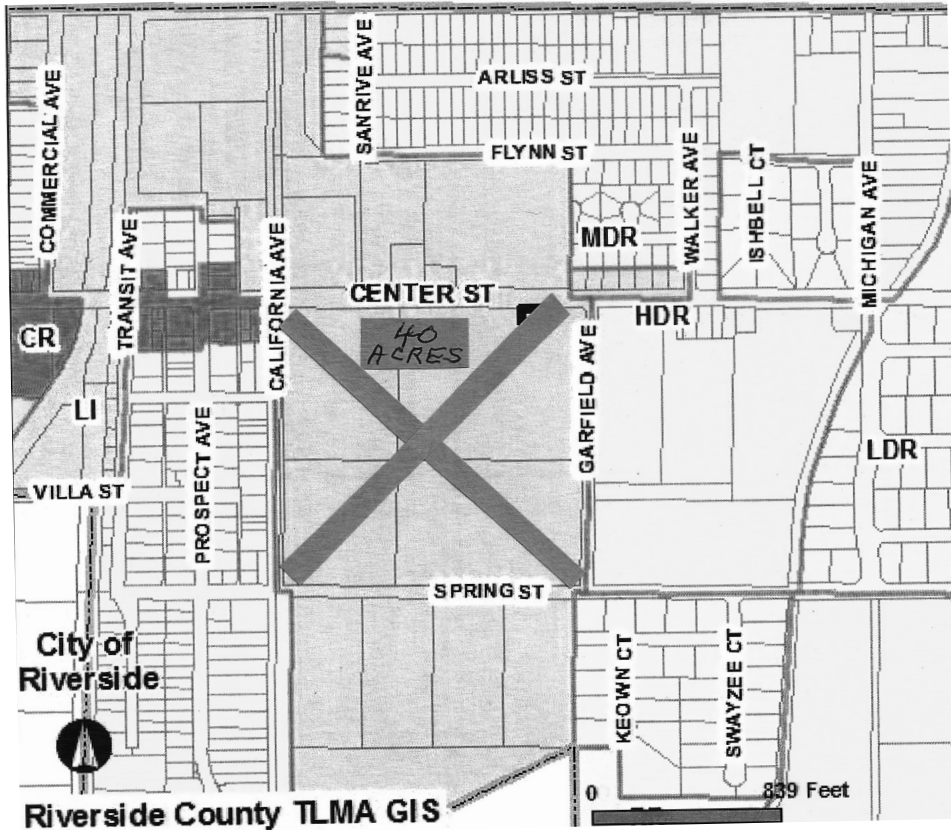

“Fast Track” plan derailed but has nothing to do with trains!

Time limit expires for warehouses on 40 acres right in the middle of Highgrove!



Some of you may remember that on Jan 13, 2009 two carloads of Highgrove residents and MAC members waited outside the Board of Supervisors meeting in Riverside for 5 ½ half hours before we were able to speak under public comments due to a previous lengthy item on the agenda. Our item did not go before the board until after 7:00 pm. We opposed “Fast tracking” the process to change the zoning of 40 acres right in the middle of Highgrove to M-SC which would allow building 11 warehouses with 586 parking spaces on the vacant land between Center St. on the north, Spring St. on the south, Garfield Ave. on the east (by the school), and the UPRR track on the west. We also submitted information that showed that neither the Highgrove Municipal Advisory Council nor the Highgrove Happenings Newspaper were properly notified in sufficient time to address this major change in our community.

A letter from the City of Riverside dated Mar. 21, 2008 also supported our position and stated in part: **“The proposed warehouse uses are thus inconsistent with the area’s existing development pattern”.....**

In spite of our written and verbal objections, the warehouses were

approved.

This article shows that Pat Meyer was not only the consultant for Bixby Land Co. who “Fast tracked” these warehouses through, but he was also the Chairman of the Board, of the First Centennial Bank when it was taken over on Jan. 23, 2009 by the (FDIC) Federal Deposit Insurance Corp. just 10 days after the zoning change was approved.

Bixby Land Co. got the zoning change they wanted, and Pat Meyer got his consulting fee for getting it passed, before his bank was taken over. But the community of Highgrove was left with the possibility of having 11 warehouses cut our residential community right in half.

Here is the good news:

On Sept. 21, 2011, I went to the Riverside County Planning Dept. and found out that the approval had a 2 year time limit which means that the expiration date for the Bixby warehouse project was on Jan. 13, 2011. Since this land is still vacant, Bixby Land Co. or any other developer would have to start the process

Fast Track cont. from P. 1 all over from the beginning because after 2 years the agreement states: "it shall become null and void and of no effect whatsoever".

So now is the time to correct this inappropriate zoning and land use!

Request for General Plan Adjustment:

On Sept. 26, 2011, I drafted a letter to Supervisor Marion Ashley, Supervisor John Tavaglione and the Riverside County Planning Commission. Here is a copy of that letter: Sept. 26, 2011

Ref.: Zone NO. 7620/TENTATIVE PARCEL MAP NO. 35612/PLOT PLAN 23256, (FTA2007-30: Applicant Bixby Land Company)

As a long time resident of Highgrove I am requesting an amendment to the Highgrove General plan concerning the 40 acre parcel in Highgrove between: Center St. on the north, Spring St. on the south, Garfield Ave. on the east and the Union Pacific railroad track on the west. My request is only related to the 40 acres that include APN numbers: 255060015, 255060016, 255060017 and 255060018.

The previous zone change was "fast tracked" over the objections of the Highgrove Municipal Advisory Council and Highgrove residents, but was approved by the Riverside County Board of Supervisors on Jan.

13, 2009.

This property was changed from Industrial Park (I-P) and Manufacturing Service Commercial (M-SC), to Manufacturing-Service Commercial (M-SC), or "such other zones as the Board may find appropriate".

The Highgrove MAC and many Highgrove residents feel this zoning and land use specified in the General Plan is inappropriate for this prime property in the middle of the Highgrove community. The present zoning designation for warehouses cuts the Highgrove community right in half and separates the older residential properties from the larger existing residential lots.

The city of Riverside also made written comments in their letter dated March 21, 2008.

A portion of their letter reads: "The proposed warehouse uses are thus inconsistent with the area's existing development pattern, particularly given its adjacency to sensitive land uses including Highgrove Elementary school, the Highgrove Library, and the surrounding established residential neighborhoods." (Note: The library mentioned no longer exists at this location due to a new Highgrove library that opened on Mar. 19, 2011.)

Jan. 13, 2011 was the expiration date for the 2 year time limit which now has deemed this project "null and void and of no effect whatsoever" for the construction of 11 warehouses and office buildings on the above mentioned property.

Therefore, I am requesting that a general plan amendment be considered to change the designation from MSC to C/R and or CI/CP zoning which, according to Larry Ross, Principal Planner of the Riverside County Planning Dept., could include a variety of services needed in Highgrove such as a retail complex with a grocery store, post office, bank, restaurant, laundry-mat, middle school, baseball fields, football/soccer fields, grass and trees, church, movie theatre, and ponds and/or lakes.

This property is serviced by the Riverside/Highland Water Company that has both potable and non-potable water on the adjacent 27 acre property on the south side of Spring Street. The president of the Riverside/Highland Water Company, Don Hough, stated that the ponds or lakes would be beneficial in helping clean up their wells due to excessive

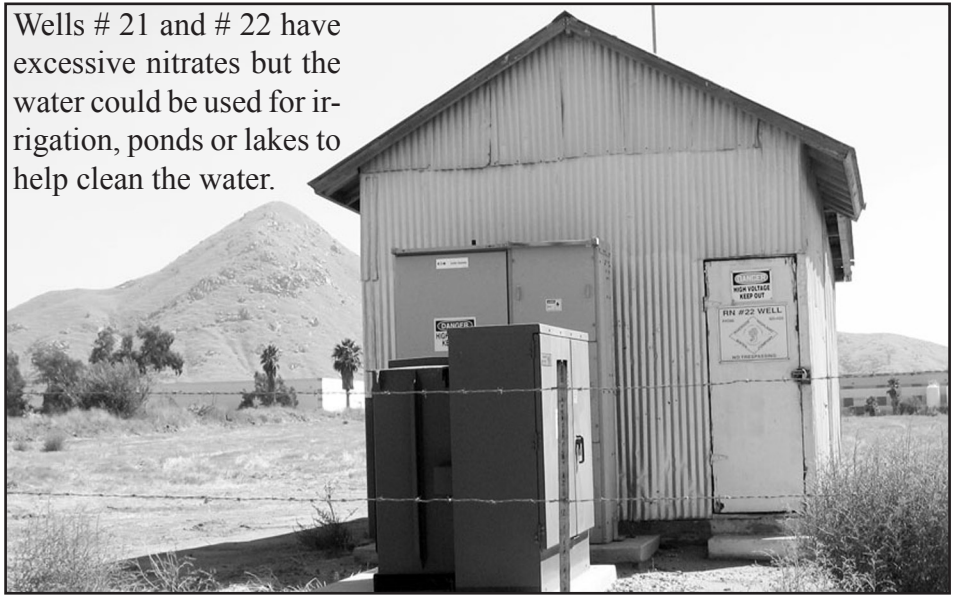
nitrates in their 2 wells located on the south side of Spring Street. This non-potable water could be used for the ponds, streams or lakes and watering grass and trees. The potable water could be used by the businesses needed in the area that could also include a swimming pool or a water park for children.

Since the proposed warehouse plans are now null and void, the timing is appropriate to request a change that would better serve the needs of the Highgrove community rather than having warehouses divide our community into 2 portions.

Please consider the request for an amendment to the Highgrove General Plan.

LAW ENFORCEMENT INVESTIGATES ROBBERIES/SHOOTINGS

On September 18th and 19th, the Inland Empire experienced several armed robberies, some of which included the discharge of a handgun. These crimes occurred on I-15, I-10, I-210, SR-91, and the SR-60 freeways within the metropolitan areas. Most of the victims were motorists who were disabled on the right shoulder of the freeway during the early morning hours. They were robbed at gunpoint by three to four male Hispanics wearing hooded sweatshirts. The suspect vehicles were described as a white, full size, regular cab pickup truck with a utility bed and rack, a red Honda Accord, and a tan Honda or Hyundai sedan. It is believed the suspects are also responsible for several other violent

crimes that occurred around the same time frames. They include two freeway shootings and an armed robbery in Mentone and another in the City of Redlands.

The California Highway Patrol, Redlands Police Department, and the San Bernardino County Sheriff's Department are committed to the safety of the public and are working together to apprehend the individuals responsible. The CHP has formulated a task force comprised of investigators and uniformed officers. The CHP has increased patrols on the affected freeways during the early morning hours.

Chevron/Subway: cont. from P 1 and Subway sandwich shop on the S/E corner of Center St. and Iowa Avenue. The new Subway opened on the same day as our MAC meeting on Sept. 28, 2011 but the Chevron station has been open a few weeks. Both the Chevron Station and adjacent Subway will have their Grand Opening on Oct. 13, 2011 from 11:00 am to 1:00 pm. These 2 new businesses are a major improvement

to the entrance of Highgrove from the I-215 freeway. Improvements such as these and the facade program could not have been possible without the assistance of the Riverside County Economic Development Agency and redevelopment funds that the State is now trying to take away from the Cities and Counties throughout the State. Hopefully, the Supreme Court will make a ruling on this issue sometime in December.

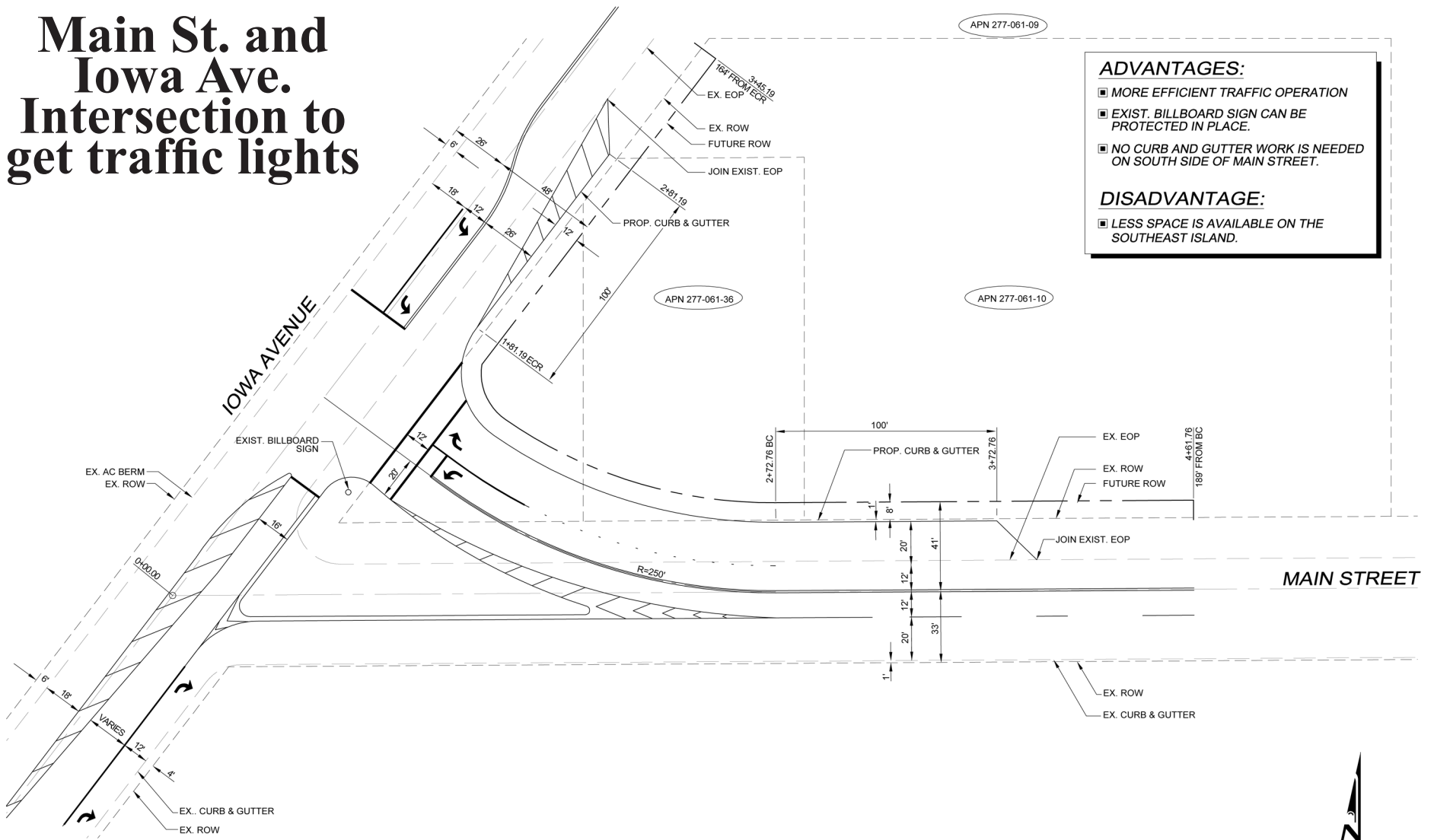

MAIN STREET AND IOWA AVENUE
CONCEPTUAL DESIGN - ALTERNATIVE 2
JAN 27, 2005



The intersection of Main St., Iowa Ave., and La Cadena Dr. has been a concern to all of us who use this intersection because the westbound traffic on Main St. has to enter the intersection on the inside of the curve making it hard to see oncoming traffic.

This problem has been addressed by the contribution of funds of \$230,000 from the Surface Transportation Program, \$50,000 from the County of Riverside and \$50,000 from the City of Grand Terrace. There were \$22,000 in Environmental and Engineering costs and \$400,000 allocated for construction and inspection. The City of Colton was the lead agency for project implementation which will include traffic lights soon

to be installed. We thank Victor Ortiz from the City of Colton for sending the information on this project. This intersection is the boundary between Riverside County and San Bernardino County and also the north side is in the City of Colton and the south side is in Highgrove which is in Riverside County. The new Grand Terrace High School is currently under construction and is straight up Main St. in Grand Terrace.

This project proves that these agencies and cities can work together for a common goal and improvements can be made that will benefit people on both sides of the county line! A big "Thank you" to all of you who made this project possible!

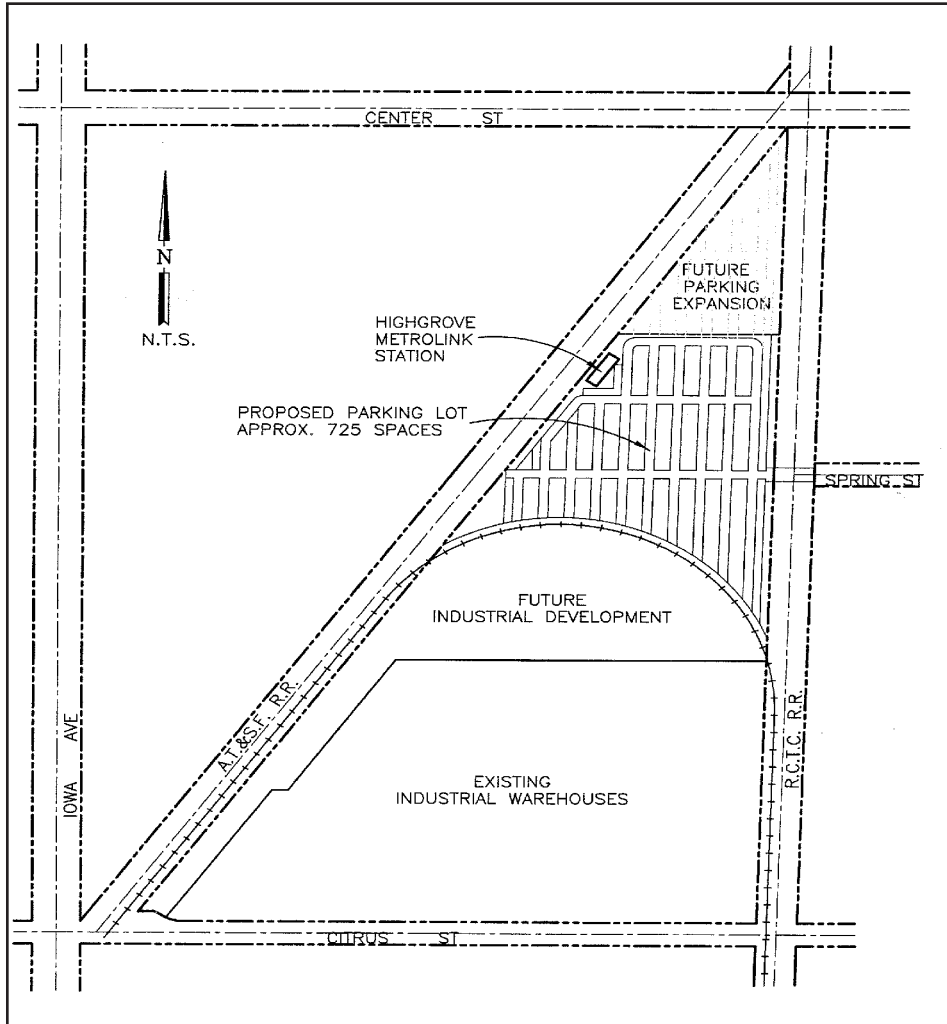

Excess Metrolink property could benefit regional transportation!



On Sept. 27, 2011, Melanie Zimmermann and I had an informal meeting in Riverside with Ann Mayer, Executive Director of the Riverside County Transportation Commission. We showed her a map prepared by our Civil Engineer that showed how the Highgrove Metrolink station would not interfere with their Perris Valley Line at all! Future Perris Valley Line trains could leave Riverside and once they get to Highgrove they could go around their new proposed curved track without stopping, and stop at their Marlborough Ave. Station. Our Civil

Engineer's map shows that there could be at least 725 parking spaces north of their curved track even without a parking structure with room to expand north of Villa Street.

Our plan was simple!

If RCTC only needs the width of a curved track to connect the 2 railroads in the 17.22 acres they own in Highgrove, then sell or develop the un-needed portion north of the curve for a regional commuter station using the existing Metrolink trains between San Bernardino and Riverside.

Ann Mayer stated that their study

showed that ridership was insufficient to warrant a Metrolink Station at Highgrove. This study goes all the way back to Jan. 10, 2007 under Eric Haley's leadership as Executive Director of RCTC when RCTC staff inflated the Highgrove location costs by improperly attaching the multi-million dollar Colton flyover costs to the Highgrove site and deflated the ridership projections through inaccurate estimates. On Jan. 10, 2007, Mr. Haley stated: **"The Highgrove station would cost \$157 Million Dollars for only 117 riders per day."** We knew these figures were incorrect when they were presented, in fact on Sept. 7, 2011 the bids closed for the construction of the Colton flyover and it still has nothing to do with the Highgrove location!

There is currently a lawsuit against RCTC from "The Friends of Riverside Hills" that is challenging RCTC's ridership figures for the Perris Valley Line.

Ann Mayer said riders will be commuting from their homes to work at the nearby warehouses in Hunter Park and she believes that most people use the Metrolink trains to get to work. But the Metrolink trains going to Oceanside were former called "Beach trains" that became so popular that they eventually expanded these trains to 7 days a week. And I am sure that most of these riders were not just going to Oceanside to go to work!

I pointed out that their station on Marlborough Ave. is on a dead-end road that ends at the base of Sugarloaf Mountain. The N/E corner has a large flood control basin, the S/E corner is occupied by Sugarloaf Mountain, and the S/W corner has conflicting railroad tracks that are

owned by the Union Pacific RR known as the Riverside Line. Highgrove has more warehouses that are closer and within walking distance than their Marlborough Ave. site.

The only corner left is the N/W corner that RCTC just bought, which is 9.75 acres that cost \$8,146,000.00 dollars of our tax money which breaks down to \$19.18 dollars per sq. foot.

RCTC also bought the 17.22 acres for the curved track at Highgrove that cost \$8,625,000.00 dollars which breaks down to \$11.50 dollars per sq. foot. My real Estate contacts tell me this is about twice what these properties are worth in today's market for vacant land. Both properties were bought from the same owner for a total of \$16,771,000.00.

In reference to selling the unused portion of the 17.22 acres for the Perris Valley Line connection, Ann Mayer stated: "Once the project is built, any excess usable land would be disposed of in accordance with state regulations and Commission policies and procedures."

We ask for RCTC to determine how much property they actually need to connect the 2 railroads before construction begins.

I reminded her that the public has supported the Highgrove location for 10 years and if RCTC continues to hold this property until after the Perris Valley Line is completed, which may be several more years, it may be perceived that RCTC is holding the public "hostage" by preventing or not developing a station on their own property that would benefit both counties. RCTC's property at Highgrove that they do not need for the Perris Valley Line should be developed by RCTC for regional transportation purposes!

Baby I Was Born This Way

I ask you to think of your most embarrassing moments in life. This left Baby ample time to read and study the books from the libraries too. Baby had to admit to himself that, all in all, the Bible was a bit depressing compared to world literature and he found a favorite author in Clemmens. This writer

could make him laugh and he needed a little humor to get through the days. The newspapers were talking about a war in Europe in this summer of 1940 and a charismatic named Adolph Hitler. His dad believed this was the Anti Christ predicted in the Bible Book of Revelations and began to preach this in his sermons, drawing more and more sick and lame onto the stage for the post sermon healing sessions and testimonials. That was the part of the show the locals really came to see in the first place. At sunrise on Monday, the packing would begin while the Reverend made his rounds to the local ministers to thank them for any and all referrals and saying good bye 'til next year. It's a Good Week to Think About Retirement Savings
Oct. 10, 2011

You may not see it posted on your calendar, but Oct. 16 – 22 is National Save for Retirement Week. This may mean contributing more to your IRA, 401(k) and other retirement accounts. Or, perhaps your investment mix may need to be reviewed to find a better balance growth potential with risk. Or you may need to take both of these steps.

- Monitor your progress. Once you've put your investment strategy into place, you'll need to monitor your progress to make sure you're on track toward achieving your retirement savings goals. Along the way, you may

VIRGINIA'S VIEWPOINT

GRAND TERRACE IN DEBT FOR A MISTAKE NOT THEIR OWN OR WAS IT?

Okay, Grand Terrace is in debt to the tune of more millions than I like to think about.

This debt is to the Valley Municipal Water District the amount of which is \$2.3 million dollars. And you know why? Because the water district made a mistake. No, I am not kidding.

You know, folks, If we owe money then it is because we did something to incur that debt. We purchased something that was more expensive than we had money to cover or some obscure reason that tell us the money concerns are ours and ours alone. But whatever the fact is: We owe it! But not in this case.

Ryan Hagen, staff writer with the Sun Newspaper (San Bernardino) stated in his article of September 13, that: "Grand Terrace learned of the debt in May, after the water district realized that in fiscal years 2008-09 and 2009-10, the county Auditor-Controller/ Treasurer/Tax Collector's Office used the wrong formula to calculate the amount the city's redevelopment agency needed to pay to the district."

If indeed that office used the wrong formula to calculate the amount owed aren't they at least partially to blame? And shouldn't the council persons do more than make statements that appear to be more like apple polishing that common sense? Somewhere along the way no one challenged this horrendous debt. Not the city manager, finance director, no one. There is more than meets the eye here. How about some enlightenment on this ridiculous situation.

The Grand Terrace city council has lots of words to try to explain what has happened but it does not satisfy me. If indeed the water company or its affiliates made a mistake then they are to blame. Simple. They should be the ones to pay it back!

THE VOID LEFT BY STATER BROS MOVE

I am concerned about the building that Stater Bros. abandoned in favor of a new location down the street that

would accommodate a larger store and more perquisites.

I heartily approve of the new store. It is beautiful and indeed has more to offer the customers, including Chase Bank and lots of other wonders.

But what are we going to do about the old building? I have learned that the leasing agent and property manager Ms. Anita McGaughey of Monarch Beach is not too concerned about the place. I discussed at length with her the fact that the building is in danger of being over run by cockroaches, rats, homeless persons, gang members learning of a choice spot for literally ruining the inside and maybe even being responsible for burning the building down. She did tell me that she had made several attempts to talk to our mayor Walt Stanckiewicz regarding the building but to no avail.

If there is something that frustrates me no end is when people that do not have the courtesy to tell you an answer to a question they do not want to talk about. Why is that? I can handle it—if you don't want to talk about it then just tell me so. Don't beat around the bush trying to answer the question by not answering it. Politicians are good at this. Know what I mean?

I talked to Ms. McGaughey at length about my concerns and the only solid piece of information I received was that she "has it covered." She did not elaborate and when I asked point blank if she hired a security guard to patrol, she evaded the question. She said she had discussed the building with a potential tenant but he told her that Grand Terrace has too many homes that are being repossessed and therefore he is not interested.

Does that have anything to do with the citizens that do not have homes that are in danger of being repossessed? We do a lot of shopping and doing other business right here in Grand Terrace. Whatever business goes into that building will need to be one that generates revenue for Grand Terrace, therefore one that

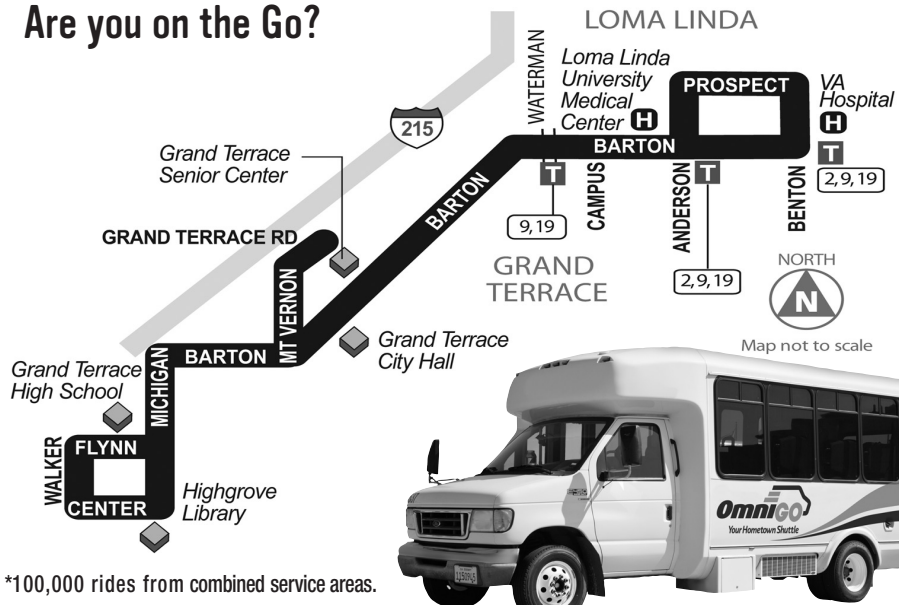
Grand Terrace High School taking shape!
